

TERMS AND CONDITIONS

1. Single ticket price is \$100 each. You may sell each ticket as a whole or in shares of \$5 each. People can buy more than one \$5 share on the same ticket. If a share is purchased, the purchaser information must be placed on the attached "Ticket Share Record" form. **For tickets that are sold as share; each purchaser must be provided with a copy of the ticket stub with the number of their ticket. 20 copies of each ticket stub will be provided to you.**
2. A person must be a minimum of 18 years of age to purchase a ticket or share.
3. There will only be 213 tickets sold. A Minimum of 150 tickets must be sold before draw date or the draw date will be extended until 150 tickets are sold.
4. "Change Your Luck with Literacy 2013" Lottery tickets are non-transferable and non-refundable.
5. Requests to sell tickets will be accepted on a first-come, first-served basis.
6. Each ticket will be sold in only one person's name on the front of the ticket and prize will be issued only to the name of the person on the ticket unless shares are purchased
 - a. **For ticket shares purchased by a group:** the person named on the ticket front will be the main contact for the group and prize will be issued only to the name of the person on the ticket front for distribution to shareholders. All persons listed on the back of the ticket will be notified of winning by phone. **NLLLC is not responsible for any disputes which may arise between the different individuals whose names appear on the ticket stub.**
 - b. For group share purchases, the person named on the ticket must also include their name and phone number in the shareholder list on the back of ticket.
 - c. **For ticket shares purchased as shares and not as a group:** Since there is no group contact person, individuals named in the shareholder list on the back of the ticket will provide their contact information and phone number on the Ticket Share Record. The prize will be issued separately to each shareholder. **If a person purchased more than one share on a single ticket, they have to write their name and number for each share purchased.**
7. A ticket is not considered purchased until a verified financial transaction is complete. All payments must be made in Canadian dollars.
8. Winners will be announced at the time of the draw. They will also be advised by mail, and contacted by phone. A full list of ticket winners and the winning ticket number will be posted within a reasonable period of time on the NLLLC website.
9. Purchase of tickets for the "Change Your Luck with Literacy 2013" Ticket Lottery entitles the Newfoundland and Labrador Laubach Literacy Council to publish and publicize winner's names and/or photos at its discretion.
10. NLLLC reserves the right to refuse participants based on non-compliance with these terms and conditions.

14. TICKET SALES IN OFFICE: Tickets can be purchased with cash ONLY in office until Thursday, September, 12th. 2013, at 2 p.m.; Mailed or faxed sales can be made until 11:30 a.m., Monday, August 26, 2013.
